These votes took place amid an unusually robust agenda of controversial bills and would not have been possible without the commitment and support of legislative leaders. Behavioral analysis is a powerful tool in the treatment of autism, developmental disabilities, and mental health problems that has proven to be very promising. It makes sense to ensure that professionals in this growing field are properly educated and licensed". Senate Trade Committee Passes Behaviour Analyst Licensing Act (1.3.19) On Monday, December 3, the Senate Trade Committee and the Assembly's Regulated Professions Committee hear testimony on the Behaviour Analyst Licensing Act (S3099/A4608) sponsored by L.A.oretti Weinberg (D-37), Senate Minority Leader Thomas Kean, Jr. (R-21), Assemblywoman Andrew Zwicker (D-16) and Assemblywoman Joann Downey (D-11).
